SUCH BOND SHALL REMAIN IN FULL FORCE, AND EFFECT, AND IN CASE OF A CASH DEPOSIT SHALL BE RETAINED BY THE VILLAGE FOR A PERIOD OF NINETY (90) DAYS AFTER THE EXPIRATION OF ANY SUCH LICENSE, UNLESS SOONER RELEASED BY THE VILLAGE BOARD.
