News from the Mayor

Another whole year has passed and what a year it's been. This month marks the end of the Village of Minoa's Centennial Year. The year that started with the Centennial Celebration in January, followed by the Centennial of the Minoa Volunteer Fire Department in April, our largest ever Easter Egg Hunt, the Firemen's County Convention being held here in June as part of the Centennial, Cruisin' in Minoa/Classic Cars on Friday nights which were combined with eight live band concerts culminating with the first ever Fall Festival in the Park.

All of these activities would not have been possible without the efforts of many volunteers, staff and Board members, especially Deputy Mayor Bill Brazill who is in charge of celebrations, and the financial support of several businesses.


We hope to expand on these Village activities this year which will hopefully include a 5K run as part of the Fall Festival. The planning is already underway for this year, anyone interested in getting involved please contact our office at 656-3100 to volunteer and/or to help sponsor one of the events.

Our DPW under the direction of Tom Petterelli built a new salt shed in house saving the village over \$100,000 in bonding for a commercial product. They also designed and built our flower benches that we have throughout the village while fulfilling the rest of their job duties. The Waste Water Treatment Plant under the direction of Steve Giarrusso and Trustee John Champagne continue to work on the CERF project with the help of interns from ESM and SUNY ESF which is developing innovative technology which is also saving money in the operation of the plant. The ESM part of the project will grow flowers to be used throughout the village next year grown in a greenhouse at the plant heated by a compost pile. The compost pile is also supplemented by food waste from Minoa Elementary and Woodland Elementary collected by the students, saving our school system money while providing more heat value in the compost.

The year also welcomed a new business Knights Delights Ice Cream owned by resident Greg Walker. Dynamax Digital Printing Inc. owned by Gale Greiner. A change in ownership in our beloved Peg and Chuck Greens Hardware has now become Greiner's Hardware under the ownership of Village residents Bob and Mary Greiner. Reminder, buy local, it's in all our best interest.

From a personal stand point I was elected by my peers in May as President of NYCOM (New York Conference of Mayors) which represents 581 Cities and Villages in the state including New York City. What a tremendous personal honor, but one I share with my Board, Staff and the citizens of Minoa, because we present ourselves at the state level as a hardworking, involved, innovative team.

The awards we have won as a village have been awards of accomplishment by a team, not an individual, which is a reflection on all of us and should be a source of pride for each of you as a resident. In my induction speech at the Annual Mayors Conference my theme was "it's not about me, it's about us". A message I'm trying, in my term of office, to spread across the state.

Electronics Recycling Law

New York State recently passed a **law** on electronics (e-waste) disposal. This Extended Producer Responsibility Law makes household, school and small business e-waste a free item to recycle, if the items are taken back through a manufacturer designated recycling program.

The Village of Minoa is a designated site. Leave your E Waste out on trash day or bring it down to the DPW for disposal.

Under this law, e-waste includes:

- **Televisions** (as well as cathode ray tubes)
- **Computers**
- **Computer Peripherals*** (Monitors, Keyboards, Mice or Similar Pointing Devices, Facsimile Machines, Document Scanners, Printers)
- **Small Electronic Equipment*** (VCRs, Digital Video Recorders, Portable Digital Music Players, DVD Players, Digital Converter Boxes, Cable or Satellite Receivers, Electronic or Video Game Consoles, etc.)

I will as your Village Trustee continue to seek innovate and alternative ways to operate the Village with the goal of keeping all of the same services. As other Towns and Villages have been forced to cut services and raise taxes, our Village, because of these innovative ideas that were initiated in 2013 have been able to keep all of our services without having to raise taxes to Village residents. We are continuing to make great strides in our research in contaminate removals in our water for improving the health of future generations, new methods to produce energy to cut the cost of Village operations, and agricultural research with our Cleanwater Education and Research Facility (CERF) with the help from ESM High School students and Suny ESF.

Starting in 2014 the Village has secured a Grant from New York State's Environmental Facilities Corporation (EFC) to research the unique ability of the Minoa Treatment plant to remove pharmaceuticals. The Village will be doing research in turning its biosolids waste into energy which will be used to fuel its pickup trucks and used to generate electricity. A greenhouse setting has been built in a donated shed that uses no energy for heat and will be operated and monitored with the help of ESM students. This will be the first of its kind in New York to produce plants and flowers in the winter making it very cost affective to do in the long winter months.

ESM students have built biological reactors to clean the water to grow plants in an aquaponics setting and raising fish in a closed loop system. These are just a few of the innovative ideas being instituted here in your Village to help you and help educate your children.

My Village of Minoa responsibilities include: Wastewater Treatment Plant, and Cleanwater Education and Research Facility (CERF), Security Camera Systems, Communications, Web-Site, Celebrations, and Emergency Disaster Preparedness Planner.

The village budgeting process begins on February 8th and continues until adoption of the budget no later than May 1st. This is a very lengthy and involved process involving submission of budget estimates by departments, preparation and filing of the tentative budget, presentation of the tentative budget to the Village Board, public hearing on the tentative budget and then finally, adoption of the budget.

General Village Election

The Village election this year is on March 18, 2014 from Noon to 9:00 p.m. at the Municipal Building on 240 N. Main Street. The last day for an individual to file an independent nominating petition for an office to be filled at the general village election is February 11, 2014. The following offices will be filled and the terms of each are as follows:

Village Justice (one) – Four year term
Trustees (two) – Four year terms each

Winter Time!!!! Please do not park on or block sidewalks in the Village. The Village plow cannot get through. When plowing out driveways and sidewalks, **make sure the snow is not placed in the roadway or on the sidewalks.**

Failure to comply with this request will be subject to violation notices and/or tickets.

Remember that from November 1, 2013 through April 15, 2014 overnight parking is not allowed on Village streets or Village owned parking lots between the hours of 1:00 a.m. and 7:00 a.m.
