Diana Abdella, 102 Kenner Road, has been made aware that there is a large amount of residents against the zone change near Minoa Elementary School

Sharlene Barkley (address was not provided on sign in sheet), concerned with traffic near the school, asked if there was a better location for this type of business, she likes the quiet non-commercial feel of the village.

Attorney Hills stated there will be an extensive environmental review completed for this project with traffic study included.

Alan Archer, 121 Edgerton Street stated he is a member of the Planning Board and this project will be reviewed by the Planning Board for Site Plan compliance, which also requires a public hearing.

Mayor Brazill thanked everyone for their comments and stated everyone will have an

opportunity to share their concerns during the public hearing on April 20, 2020 at 6:30pm. At this point in time the board has only received a conceptual plan of the development, there is a process with extensive reviews for environmental impacts, traffic studies, stormwater drainage as well as County Planning Review. As soon as we have a better understanding and site plan proposal of this development we will be able to share it with the public and begin the review process.

### **COMMENTS - OTHER TOPICS:**

Tom Czajak, president of Minoa Fire Department Inc reminded everyone that on the election ballot there is a proposition to increase the service award contribution from \$700 to \$1200 for qualified fireman, the last time this amount was increased was in 2004, the village board has approved the increase contingent upon mandatory referendum.
