ONONDAGA COUNTY LEGISLATOR MARK OLSON DISTRICT 10 Legislator Mark Olson thanked the board for the opportunity to present his report to the community of Minoa. Mr. Olson stated he is a committee member of the Public Safety, Planning & Economic Development, Criminal Justice Advisory Board, Soil & Water Conservation District Board, Stop DWI Advisory Board and Syracuse Metropolitan Transportation Council (SMTC)

2025 Onondaga County Budget

- 9% property tax rate reduction
- Continued investment in housing initiatives
- Continued investment in mental health programs in county schools
- \$450,000 for the Onondaga County Sheriff's Office (vehicles & training)
- 15 new positions in the Department of Children and Family Services
- 4 new positions for the Board of Elections
- Substantial investments in foster care and daycare programs
- Increased funding for lead initiatives (on top of the County's \$14 million dollar 'war chest' for lead remediation)

Public Safety

A comprehensive EMS study will be conducted and will look at everything from 911 dispatch through hospital care. It will examine what is currently done with input from local EMS providers, hospitals and emergency management/911 officials. The study is expected to be complete in about one year and will result in recommendations on how to improve our EMS service while looking at how to best sustain it for the long term and continue providing vital services to residents.

In the 10th District we are fortunate to have Minoa, Fayetteville and Manlius as transporting EMS agencies.

RESOLUTION IN SUPPORT OF CONTINUED / INCREASED STATE AID FOR LOCAL GOVERNMENTS

Trustee Christensen made a motion, seconded by Trustee Abbott to adopt the following resolution:

Resolution in Support of Continued and Increased State Aid for Local Governments

Whereas, until 2024, cities, villages and towns had not received an increase in unrestricted state aid (AIM funding) in 15 years, significantly impacting their ability to provide essential services to their residents; and

Whereas, after a prolonged period without financial support, local governments finally received an increase of \$50 million in unrestricted state aid; and Whereas, local officials express their gratitude for the \$50 million increase in unrestricted state aid, recognizing it as a positive step towards addressing long-standing funding challenges; and

Whereas, the State has referred to this new aid as Temporary Municipal Assistance, suggesting that such increase may not continue, jeopardizing the sustainability of crucial municipal programs and services; and **Whereas**, the property tax cap further limits the ability of local governments to

properly fund the programs and services their residents need; and

Whereas, increased and ongoing state aid for local governments is vital for
maintaining infrastructure, public safety, housing and other municipal services; and
Whereas, the challenges of inflation, the increasing costs of labor and supplies,

and the end of extraordinary federal aid only accentuate the need for consistent and predictable funding to effectively plan for the future and meet the growing needs of their residents;

Now, therefore, be it resolved, that the Village of Minoa calls upon the Governor and the State Legislature to commit to continuing the additional \$50 million in unrestricted state aid in the 2025-26 State Budget and beyond, and **Be it further resolved**, that the Village of Minoa urges state officials to recognize the need for a long-term plan that ensures consistent and predictable increases in financial support for local governments that keep pace with inflation. **THIS RESOLUTION WAS ADOPTED.**
