News from the Mayor

Wow, it's 2010 which means a new year, a new decade, and a fresh start. A new year always brings new or revived resolutions, a hope for a great year, and a chance to regroup after the holidays.

We are now past the halfway point of our fiscal year and the beginning of the formal budget planning process for the 2010-2011 Fiscal Year, which begins on June 1, 2010. This year is going to be a year full of challenges, not the least of which will be providing the same level of services with fewer dollars to complete the work. Local government depends on monies from other levels of government to help us keep the tax rate down and still provide consistent services. We receive Sales Tax revenue from Onondaga County, and Aid and Incentives to Municipalities (AIM) and CHIPS Capital from New York State. The funding for these programs are made by you, the taxpayer, to the respective governing bodies and you rightfully have the expectation of receiving a benefit back in your community for your hard earned money.



The Sales Tax formula contract with Onondaga County is currently up for negotiation for the contract beginning in 2011. The last contract covered a ten year period and the County Executive wants to drastically change or eliminate giving local government their share. New York State does not mandate that the County has to share tax revenue with municipalities. Each and every one of us contributes to the Sales Tax pot every time you make a purchase and you have a right to expect to receive a benefit from the Sales Tax directly back to your community. The Governor is also looking to cut funding for AIM and CHIPS programs. As I've discussed in the past, we still have unfunded mandates to deal with and I expect more in the upcoming budget year.

My intention is to present a budget to you later this spring that will hold the line on taxes. Given the above scenarios, it is going to be a daunting task indeed. Last month I restricted spending from the current budget in preparation for the upcoming year. The Board had considered purchasing a ladder truck for our Fire Department, but due to the hostile financial climate, a decision was made by the Board to reject all of the bids presented. There is no magic here, if you can't afford it, you can't buy it. Infrastructure and equipment need to be maintained, replaced and/or scheduled for a later date and it's the Board's responsibility to choose the option that makes the most sense. If not maintained properly, the end result will be more monies spent unnecessarily. As we do every year, services will be thoroughly scrutinized. I have a great Board and staff members that are always looking for different ways to do things that will make us run more efficiently.

I will continue to be involved in discussions relating to shared services and potential consolidation with all levels of local government. The one thing that can't happen is for us to lose our grass roots government. Bigger government proves every day that it is not better. Our Federal and State governments are the single largest employer in each of their jurisdictions, yet they are unwilling to restructure and modernize the way they do business. Saving the taxpayers any substantial amount of money will only come from making real changes at the top. My attempt to try to make a difference at the State and Federal level is by being involved and assuming leadership positions to help create a united front with my local and statewide colleagues through the Onondaga County Mayors Association and the New York State Conference of Mayors (NYCOM).

We need your help and support to continue the fight against unfunded mandates and to resist cuts in aid, especially when they are unwilling to look inward and make changes that make a real difference to all of us at this level. Below is a list of elected County, State and Federal officials that represent Minoa. Have you ever contacted any of them? Please think about it, because change will only happen if we all work together. We didn't get to where we are overnight, to change for the better won't happen overnight either and we have to start somewhere.

The New Year will also bring a change in our Village Board. As you know, Trustee Ed Theobald was elected as the Town of Manlius Supervisor. I will miss Ed's dedication to our Village and his participation as a part of a terrific Board; however, I'm excited that he will now represent us at the Town level. He, too, will have major challenges; I wish him well and look forward to working with him. His leaving creates an open position on the Board, which by law will be filled in the March Election to finish the remainder of his four-year term. In the interim, I will not be appointing anyone to his position due to the short amount of time the position will be open. I have had a few people show interest in the position and they have asked what the expectations are in terms of time and responsibility. To do the job correctly a Village Trustee works approximately 15 hours per week. The hours vary depending on the assigned responsibilities and the time of year. If anyone is interested in running for election and needs information, please feel free to contact Clerk/Treasurer Suzanne Snider for details.

While 2009 was a productive year for our Village, we will continue to concentrate on new and innovative technology for all of our departments, as well as continually searching for new funding sources to offset expenses. Included in this newsletter are statements from my Trustees detailing what we've accomplished this year.

On behalf of my Staff and the Village Board, I wish all of you a safe, healthy and prosperous New Year.

A Word from your Trustees

What an interesting year 2009 has turned out to be! There have been a lot of challenges for the whole country and for the state of New York. As a Village Board, we have taken every step possible to run the village in more efficient ways and still provide the same services to the residents of the village.

I worked diligently with Thomas Petterelli, Steve Giarrusso, Trustee Cronk, National Grid and NYSERDA to receive funding through the Energy Audit Conservation Program in the amount of \$12,459 to upgrade the lighting systems at Fire Station II, DPW, Waste Water Treatment Facility and the Municipal Building. The program provided more energy efficient lighting and I estimate that the Village of Minoa will save approximately \$5,000 annually on energy costs. I have also been working with Steve Giarrusso, Waste Water Treatment Facility Supervisor, on different ways of saving operational costs at the plant.

We are still working on an alternative fuel vehicle for the DPW and we were able to secure a \$60,000.00 grant toward the conversion of a diesel trash truck to a compressed natural gas (CNG) trash truck. The truck will be quieter, will have fewer fumes and be more environmentally friendly. The CNG garbage truck will use just about the same amount of fuel a diesel truck will use, but at one half the cost of diesel fuel. We will continue to look for ways to become more efficient at the least amount of cost for the village residents.

It's hard to believe that my four-year term as a Village of Minoa Trustee is almost up and the last four years have been an interesting learning curve for me. I have learned that it takes a lot of time and dedication to fulfill this role. I have come to the conclusion that all the time and dedication I have given to the Village of Minoa has been a rewarding and fulfilling experience for me. I look forward to the upcoming election and hope to continue making the Village of Minoa a better place to live and work. Please have a safe and healthy New Year!

I am looking forward to working with and for all of the people in the Village of Minoa this New Year. As liaison for the Department of Public Works, I am pleased to report that National Grid was able to provide Efficiency Rebates towards the purchase of a boiler and two heating units at the DPW with the goal of reducing utility bills from the energy efficient changes that were made.

The DPW has been busy throughout the year by providing snow removal for over eleven miles of road, repairing sewers, trash removal, and maintaining our parks. The Village of Minoa owns and maintains approximately 250 trees throughout the village, which includes trimming, taking down and planting new trees. I am pleased to report that we have benefited from participating in National Grid's 10,000 Trees Program, which provided the Village with \$500 this year towards planting utility friendly trees.

This next year will be financially challenging due to the expected reduced aid from New York State based on the shortfalls in the current economic climate. It will also be difficult to maintain consistent services that we are used to and still maintain the same tax rate. It is an honor to serve as your Deputy Mayor and 2009 has been a great year for the Village of Minoa. We've seen interest throughout the past year for growth in our Village by investors. The Planning Board recently approved a Site Plan Application for the properties located at 101 and 107 N. Main Street for Trapper's II, which is a restaurant and pub that will have a volleyball court and horseshoe pits. The new Trapper's II is scheduled to open in early Spring 2010 and you can follow the progress via Facebook. The property owner has great plans to revitalize that area and we look forward to their new business.

The Village of Minoa also annexed the properties located at 6439 & 6441 Schepps Corners Road (N. Main Street, north of Minoa Elem. School) owned by New Plan East, LLC this past spring and we hope to see further development of those properties in the future.

Minoa Farms continues to build new homes and they are in the process of developing a passive park with nature trails for walking. The park is currently located on private property and when ownership is turned over to the Village of Minoa we will post the announcement on the sign at Lewis Park and on the village website.

Rees Field has been revamped with a new fenced in basketball court, pavilion and picnic tables through funding from Onondaga County Community Development. Over the years through their funding and Village contribution, we have torn down the old municipal building, upgraded the backstop in the baseball diamond and installed a parking lot for the field. Currently the basketball court has been converted into an ice skating rink for winter fun, so please stop by and visit Rees Field which is located on Osborne Street.

As a member of the Town of Manlius Critical Response Committee, I'm always working hard to find better ways to prepare our Village Board, staff and community in the event of an emergency. Throughout the past year I've been busy working on organizing emergency drills and working through different scenarios with other local municipalities, EMS, police, fire and emergency management organizations, so that we are always prepared should a disaster occur in our community.

Carbon Monoxide Detectors Required Under New Law

Amanda's Law, passed in the 2009 Session of the New York State Legislature, will establish a new requirement for installation of carbon monoxide detectors in homes. Under the law, one-family homes, two-family homes, dwellings located in condominiums or cooperatives, and multiple dwellings must have a carbon monoxide detector installed regardless of the date of construction or sale.

The law was named after Amanda Hansen, a teenager whose life was tragically ended by a carbon monoxide leak from a defective boiler while she was sleeping at a friend's house in January 2009. The new law requires that the carbon monoxide detector be a device meeting New York State standards, and that it be installed in an operable condition in dwellings where there are appliances or systems that may emit carbon monoxide or have an attached garage.

Prior to Amanda's Law, carbon monoxide detectors were required in one-family dwellings, two-family dwellings, and dwellings located in condominiums or cooperatives only if they were constructed or offered for sale after July 30, 2002. For multiple dwellings (such as a tenement, hotel, and dormitories) carbon monoxide detectors were required if they were constructed or offered for sale after August 9, 2005.

As a result of Amanda's Law, a carbon monoxide detector will be found in nearly all residential structures in the state. This creates a safer living environment for New York residents and creates a greater awareness of home safety issues that are intensified by seasonal heating issues prevalent in the Northeast.

Amanda's Law takes effect on February 22, 2010.

The Senior Adult Transportation Bus Service to Start

The M-B-K Ecumenical Council is proud to announce the start of its Senior Adult Transportation Bus Service, an affordable, curb to curb, specialized transportation service for seniors and disabled residents of the Minoa-Bridgeport-Kirkville area. Beginning January 4 the new 14 passenger handicap accessible bus will operate Monday through Friday, 9-4 pm on an on-call basis in Minoa, Bridgeport and Kirkville. Reservations must be made one week in advance to 315-454-2740. Trips will be provided for medical appointments (doctors, hospitals and physical therapy), grocery shopping, and the SAM program. Transportation is limited to seniors and residents with a mobility handicap. A donation of \$5 per roundtrip is suggested. The bus is wheel chair accessible and easy to enter. Riders in manual wheelchairs must be accompanied by their own aide.

During January the bus service will be introduced to each of the seven churches in the M-B-K Ecumenical Council. A Dedication Ceremony will be held on Saturday, January 23, 1-3PM at the Minoa First United Methodist Church. Volunteers, the public, and all those who through their donations and efforts helped to make the bus possible are invited to attend. Sister Francis James Paris of the Ecumenical Council commented; "Our Senior Adult Ministry is rooted deeply in our commitment to building community and serving our seniors; enabling them to continue to build balanced social, spiritual, emotional and physically safe lives by providing for their necessary transportation needs."

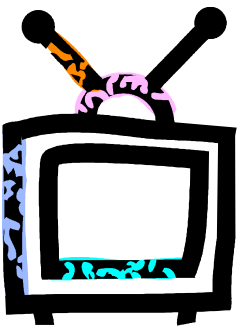

A Word from the Minoa Ambulance

The H1N1 strain of flu is affecting primarily the very young and also pregnant women, but it is having very little effect on the elderly at this time. There are 5 priority target groups at this particular time to receive the vaccinations (these are in no particular order):

- Young and Healthy (ages 6 months - 24 years old)
- Health Care Workers (pre-hospital and hospital workers)
- Pregnant women
- People ages 25-64 with chronic health conditions
- People who are around small children under 6 years of age

There are two versions of the vaccine; aerosol version, which can not be taken by pregnant females or people with chronic respiratory diseases, such as asthma because this is a live version of the vaccine. The other version is the standard injection which is a benign version of the drug. It is recommended to receive both the seasonal flu vaccine and the H1N1 vaccine.

Symptoms are similar to the seasonal flu, but can include difficulty breathing, skin discoloration, dehydration, persistent or severe vomiting, pain in the chest or abdomen, and dizziness. It is recommended to have no contact with anyone while you have a fever and should stay out of work/school until at least 24 hours after the fever has subsided. The best prevention is good hand washing and covering your mouth and nose when coughing and/or sneezing.
